Guest Speaker: Ben Harder, Crossroads Planning & Development LLC presented information regarding recent LTWP Trustee contract for consulting assistance in creating overlay for the Buckeye Lake District. A discussion took place.

*Old Business:* Mr. Matthews tasked the ZC to read the Buckeye Lake draft language for Article 11 Short Term Rentals; Solar and Wind farms language; billboard language; and become familiar with the process for text amendment timeline and process.

Zoning Inspector: Mr. Moraine requested the Zoning Commission create/draft a separate zoning district for Avondale and Harbor Hills; discussed overlay districts & mixed use zoning; expressed concerns regarding zoning pertaining to short term rentals (ie Airbnb/VRBO).

Mr. Moraine stated that this is not a township matter but rather a state route which needs addressed with ODOT. Mr. Moraine said he would bring it forward to the Trustees.
